## **GVRA Business Enterprise Program Staff Updates**

- Program Manager's Update, Bobby Goodman
  - Credit Card Competition Act goes into effect next week
  - Restructuring BEP
  - Opened Palmetto Post Office last Friday, Cheryl Hodge is the assigned vendor
  - TSA Airport will be revisited in November. John Sanders is the assigned vendor and placement has been delayed due to unforeseen circumstances.
  - CDC, FEMA in Chamblee, DDS Norcross, and Royal are combining to make a vending route. Currently, two temporary vendors are doing the vending
  - Locations at the Capitol are getting another vendor or temp assigned to it as it is not making enough money to be sustainable.
  - Opening a new nanomart at Georgia Department of Public Safety.
    The site will be assigned to a trainee or temp to get data on sales.

# - Contracts Update, Tara Woodford

- 10 locations have transitioned from Third Party Vendors to licensed blind vendors
- Realignment document describes satellite as in same county as stand-alone, if another county it is an attachment
- FLETC contract was just completed
- There is a 4 month deployment out of Fort Stewart from November-February. RFI has been sent to teaming partners. Solicitation for Fort Stewart will likely occur first of January.

# - Equipment Update, Danny Murr

- Repairs/Maintenance for Federal Fiscal Year 2023
  - Facility: \$70,817
  - Vending: \$213,133
- Amount for repairs was so high because repairs techs had to make more than one trip for many of the repairs
- Process for repairs now is that vendors contact consultants and consultants contact techs and techs contact Danny
- Waiting on prior approval from RSA for Federal Fiscal Year 2024
- Training Update, Will Graham

- 3 provisional vendors: Joanne Bush, Shelby Ball, Xavier Hayes
- 6 candidates: Charles Almond, Eric Green, Donna Harvey, Cass Phillips, Michele Scandrick, Derick Whitaker, Derrick Riddle, Cassius Harding
- Refresher training will occur prior to interviews
- Training class is tentatively scheduled for April 2024 and will likely occur at Warm Springs

## **CBV General Discussion and Business**

- Wesley Vaughn presented motion on liability insurance
- CBV members discussed reducing set-aside from 8% to 6%. Members acknowledged that it is easy to drop the rate but might not be easy to raise it in following years
- Michael Armstrong led discussion of vendor access to Team Georgia Marketplace
- Zach Thomas presented policy to remove the 70% or 210 score for awarding a facility. Highest score of bidders should win.
