- Inability to maximize VR Grant we will again send back federal monies that our state will not match – this is a shame for our state – these federal tax dollars paid by the citizens of Georgia are being sent back to the federal government- these are funds that could be used to serve Georgia's citizens with disabilities
- Sustainability of Georgia Industries for the Blind (GIB)
- GVRA prepared to commit to possible furloughs to cut cost if necessary possibly 2 furlough days per month --- but right now we feel we have made significant improvements and will not have furlough
- Furlough Discussion will need permission from the board to proceed with furloughs -do not feel it is necessary at this time - if it becomes necessary to take this action, the board will need to decide to meet in January for a decision
- GVRA's Finance Office has centralized budget controls
- GVRA is consolidating offices to help with cutting costs
- Ed James presented qualitative information regarding the opening of Category A on Oct. 1st
- Continuing to develop partnerships with other state agencies
- Think Big, Serve More People, Do Better focus mantra
- Kevin Harris presented update on PR / external relations / calendar reminders
