DAS Overview

- 100% federally-funded program that operates under an agreement with the Social Security Administration (SSA) to make disability determinations for Georgia citizens who apply for entitlement programs administered by SSA
- Five (5) DAS locations Athens, Dalton, Savannah, Stone Mountain and Thomasville
- Staff count 400+



Federal Fiscal Year 2019 Accomplishments

- Processed 99% of budgeted workload by closing 126,129 cases
- Production per examiner (adjudicator) was the 3rd highest performance in nine (9) years.
- Reduced the disability hearings backlog by 69%
- Became the fourth state in the Atlanta Region to roll out SSA's new national Disability Case Processing System (DCPS)



Federal Fiscal Year 2019 Accomplishments Cont.

 Cooperative Disability Investigations (CDI) Unit, in collaboration with federal and state partners (SSA and GBI), accounted for \$4,192,655 in SSA savings; \$4,310,946 in non-SSA Savings; and \$326,891 in SSA monies.



Federal Fiscal Year 2020

- DAS has been assigned a workload goal of 116,210 total cases for FFY20.
- Through Friday, February 28th closed 54,021 cases 24,191 of which were Initial cases
- Expand the DCPS Pilot
- Stabilize its staffing levels across the state






State Fiscal Year 2020 GVRA February 29, 2020 Financial Performance Chart by Program

Legislative Update

- HB 804- Relating to the "Georgia Equal Employment for Persons with Disabilities Code," so as to prohibit employers from discriminating against individuals with disabilities by paying less than the required minimum wage.
- SB 383/HB 383- to Create the Commission for the Blind and Visually Impaired
- HB 842- "Gracie's Law"; to prohibit providers from discriminating against potential organ transplant recipients due solely to the physical or mental disability of the potential recipient.



FY19 Highlights

Nine Centers for Independent Living & One satellite office

•Centers for Independent Living served 2,422 people with disabilities across the state of Georgia.

•Of the 2,422 people served, 1,227 were new individuals to the Centers for Independent Living.

 167 people applied to be transferred from institutionalized settings into the community – 80 people were successfully transitioned into the community of their choice.

•Of the 2,422 people served, 58 percent successfully reached their independent living goals.



FY19 Highlights

- Centers for Independent Living provide five core services – Information & Referral, Peer Support, Independent Living Training, Transition into the Community, and Advocacy
- The Centers work closely with the Georgia Vocational Rehabilitation Agency, Division of Aging Services, Georgia Council on Developmental Disabilities, the Department of Community Affairs and the Aging and Disability Resource Connection. In fact, many of the referrals we receive are from the Aging and Disability Resource Connection.
