Opening and Welcome

2026 Legislative Session

- Mr. John Pilgrim, Legislative & Governmental Affairs Liaison, provided an update on the 2026 Legislative Session. He shared bills that he is watching that may have an impact on GVRA and the Legislative Session calendar. He also shared that GVRA will host GVRA Day at the Capitol on February 10th from 12:00 pm to 4:00 pm.

Chairman Wilson encouraged all Board members to participate and present solid support at the Capitol.
