

- Administration
 - Policies and Procedures
 - COVID 19 Guidance (Teleworking)
 - \$1,000 One-Time Payment for Eligible Employees
- Lease Portfolio Utilization
 - We have evaluated our portfolio of leased locations and identified opportunities to better utilize certain leased spaces
 - Strategies being explored are:
 - Moving from less desirable office locations to increase utilization and address other leasehold issues
 - Subleasing unused space when the location is desirable and the rents are reasonable
 - Consolidating administrative leased space to one floor
 - Will incur some upfront costs related to moving and office buildouts
 - Anticipate long term savings savings estimates are in process
 - Utilizing existing furnishings to minimize the cost of the office moves






VR Reorganization Updates

 - Phase 4 culture, training, data driven examination


























Vocational Rehabilitation

February 2021

- 136 counselors (counselor 1 = 49 and counselor 2= 87)
- 40 Pre-Employment Specialists
- 17 Employment Specialists
- 82 Office and Counselor Assistants
- 17 Supervisors

As of February 10, 2021

- 22,140 individuals being served
 - 7,566 potentially eligible students
 - 1,305 new potentially eligible students
 - 743 individuals successfully secured employment and maintained for 90 days
 - 3,354 individuals exited without employment
- January 1st- Closed Priority Categories 2 &3
 - As of February 12, 2021 341 VR clients in Delayed Status
 - Does not impact potentially eligible students

Blind Commission Legislation

- Create a Blind Commission with the mission of overseeing cradle-to-grave services for individuals who are blind or have low vision
- Provide for the appointment of five (5) members, a paid Executive Director position, the authority of the Executive Director to hire personnel, and the signatory authority to rent/lease property
- Would transfer supervision of Georgia Industries for the Blind (GIB) to the Commission, with the Department of Human Services (DHS) providing for equipment, maintenance, facilities management, and supplies
- Would establish Commission as State Licensing Agency for Business Enterprise Program (BEP)
- Would require development of a state plan for delivery of vocational rehabilitation services to individuals who are blind
