




Organizational Chart- Executive Leadership






Organizational Chart - Administration

Client Services

- As of this week, 35 Counselors, 18 Pre-Employment Specialists and 15 Office Assistance have been selected and are being processed for hire.
- David McConnell is the new District Manager for District 5, effective September 1, 2022.
- Since July 1, 2022, 257 clients have been closed successfully

Disability Adjudication Services (DAS)

- DAS has met its total workload goal for FFY22 by processing 92,539 cases as of September 2, 2022
- DAS has hired 37 staff members FFY-to-Date (since October 1, 2021)
- New Adjudicator Basic Training Class of approximately 20 is expected to start on September 16, 2022

Overview

- BEP is the State Licensing Agency (SLA) designated by the Randolph Sheppard Act (RSA) to provide economic entrepreneurial opportunities.
- Has created financial independence for the blind citizens of Georgia since 1944.
- Blind Vendors manage vending routes, coffee shops, snack bars, smoothie bars, micro-markets, cafés, and military dining service facilities, as well as the interstate roadsides and Welcome Centers.



BEP Vending and Snack Facilities:











- Clients referred and accepted into the Business
 Enterprise Program from Vocational Rehabilitation
 Services and are trained to become a Licensed Blind Vendors.
- Currently we have over 190 vending facilities
 - 104 vending facilities (stand alone)
 - 63 attachments
 - 23 full service
- Currently have 52 License Blind Vendors

The Path Forward/Post Pandemic


- Funding Guidelines
- Modernize current service delivery models
- Implement TAC 21-02
- Convert third party vending on non-federal property to blind operated
- Place electronic payment services on existing equip
- Establish non-traditional vending facilities such as food truck, ghost kitchens, etc.
- Establish non-food related businesses (i.e., laundromat, dry cleaners, retail shop, etc.)
- Establish vending facilities in private sector (convenience store or sub shop in strip mall or stand-alone building

Business Enterprise Services

- Georgia Industries for the Blind (GIB) was authorized in 1937 with the passage of House Bill 114 to provide jobs in manufacturing, packaging and services for individuals who are blind.
 - Manufactured products include pillows, safety vests, classification folders, cloth reusable facemasks, and first aid bags.
 - GIB operates in three manufacturing facilities located in Bainbridge, Griffin, and Robins Air Force Base.
- GIB is affiliated with National Industries for the Blind (NIB) and acquires federal contracts under the Ability One Program.
- The Ability One Program requires that GIB maintain a 75% blind ration in the direct labor category.
- Number of Employees: 53 full time and 5 temp employees









- The AbilityOne Program is a preferred source of supplies for federal employees
- Government agencies <u>prioritize the purchasing of products to</u> <u>suppliers that employ individuals who are blind</u>
- 75% of the organization's workforce must be either blind or legally blind.
- NIB provides technical assistance and negotiates contracts on behalf of its agencies
- Georgia Industries for the Blind is one of 100+ agencies that NIB supports



- GIB is the manufacturing partner for Rustic Outdoors
- Rustic Outdoors is in negotiations with a major retail outlet to sell their products nationwide
- Partnership with GIB was a major selling point

Work-Based Learning (WBL)

- A transitional job-skills training program which lends instruction to developing employability skills.
- Successful participation in WBL can lead to students acquiring skills for employment beyond high school.
- GAB proudly salutes 10 graduates who are on a job path beyond high school after completing job skills training.
- GAB's WBL community partners include Goodwill, Macon Outreach, Kroger, Marriott Courtyard, Magnolia Manor, Papa Johns and GIMC.



Project SEARCH at Atrium Health Navicent

- GAB's Pinnacle Transition Program: Cohort VI!
- 1-Year Internship for graduating seniors
- Interns work towards post-graduation competitive employment opportunities.
- A focus on transferable work and life skills
- All areas of the ECC are covered.
- Interns must meet eligibility requirements for GVRA.
