- Crystal stated that the only time the VR Policy Unit will make changes is if they find a pattern of things happening instead of creating exceptions, and if it is the right thing to do.
- She stated they will work on a final draft on the proposed policies this week
- Crystal explained that the timeline was to have the policy changes the policies done and implemented by May 1st.
- **Rossany Rios** suggested tabling the discussion of the location, dates and number of public hearings for the SRC meeting on Day 2.

SRC Chair, Rossany Rios open the meeting and Introductions were made.

GVRA Executive Update by Sean Casey

- Spoke on the 2018 legislative session.
- Addressed one goal this year is to ask for more money from the legislator for the counselors.
- Spoke on employing more counselors.
- Discussed the return on investment of hiring VR clients from the "Fast Facts" brochure.
- Talked on how the Agency is part of a group whose goal is to introduce legislation making Georgia an Employment First state, so they are in the process of working with legislative council now on the language.
- He mentioned the recent survey on the VR Program and stated the results will be available at the next meeting.
- He discussed the partnership with the Carl Vinson Institute out of UGA to provide leadership training. The reason for this partnership is to address a GVRA weakness, which is turnover.
- He also mentioned the first student graduation at Cave Spring Center.

VR Programmatic Update by Dale Arnold

- Spoke on the Support Services Unit and its different functions.
- Spoke on hiring staff to work with individuals with developmental disabilities.
- Discussed the 2nd Evolution Conference to be held in July.
- Mentioned that Teresa Eggleston, Director of Support Services, is involved in a project at Fort McPherson to increase capacity for accessible, effective, comprehensive and evidence-based recovery support services for veterans.
- Discussed the Sensory Unit which encompasses Blind and Deaf Services.
- Stated they have selected Jared Patton as Assistant Director for Deaf Services and Shirley Robinson as Assistant Director of Blind Services.
- He commented on working with HR to develop training for staff around sensory services and cultural sensitivities related to Deaf and Hard of Hearing and Blind and Low Vision.
- He stated that this training will also be offered to the Employment Services Unit staff so they understand the complexities of those disabilities and the cultural sensitivity necessary to work with this group.
- He also discussed the Compliance and Policy Unit activities with policy changes.
- He commented on Transition Services.

GVRA Staff Support to the SRC presented by Kevin Harris

- Spoke on how GVRA has made operational changes like separating Communications and Marketing from External Affairs
- He discussed making sure the SRC members, especially SRC Committee Chairs, make sure who to contact as their GVRA staff support person

Public Hearing Discussion

- Locations were discussed and six were agreed on by the SRC.
- The locations were: Savannah, Macon, Augusta, Atlanta, Gainesville, and Albany.
- Justin Pressley made the motion to approve the six (6) locations and Brian Mosley seconded
- All SRC members agreed
- Robin and Jacqueline will set up the public hearings and work with the GVRA Policy unit and Office of Communications and Marketing on the details to make them accessible and get the legal notices in the newspaper for each city where a hearing is being held
- Once Robin receives the final proposed policy change document, it will be emailed to the SRC and provided to the Communications Manager
- Written public comment will also be received online
- Robin and Jacqueline will strive to have the six public hearings end about two weeks before the May 1st deadline

- He gave updates on SILC activities, subcommittees, and more

 - CILs Expansion Continue seeking funding to expand the CILs coverage to include more than 50 counties without services.
 - ➤ Home Access Program Retain or expand funding assistance for low income individuals with disabilities to retrofit their housing so that they can safely navigate their homes. Funding has been reduced to \$100,000 annually.
 - Waiver Expansion Seek additional funding for ICWP, CCSP and other waiver programs that enable individuals with disabilities to live in their communities and not institutions.
